## **REGULATION**

### **ON THE COMMITTEE FOR THE SPORTS**

#### **of the International Council of Amateur Sports**

1. The Committee for the sports of the International Council of Amateur Sports is the executive body of the International Council of Amateur Sports, which carries out international coordination and functional regulation in the field of the sport concerned, and also develops and implements measures to develop the amateur sports movement.

2. The Committee for the sports of the International Council of Amateur Sports is guided in its activity by the World Charter of Amateur Sport, by international and national constitutional laws, by orders and decisions of the Secretary General and the Secretariat of the International Council of Amateur Sports, and by this Regulation.

3. The Committee for the sports of the International Council of Amateur Sports carries out its activities in cooperation with other Sports Committees, profile commissions and working groups of the International Council of Amateur Sports, international and national sports organizations, executive authorities of all levels, local governments, public associations and other organizations.

4. The main tasks of the Committee for the sports of the International Council of Amateur Sports are:

- 1) coordination and functional regulation in the field of the relevant sport;
- 2) development and implementation of measures to develop the amateur movement in the relevant sport;
- 4) development of the material and technical base of amateur sports and sports tourism, as well as the development and implementation of proposals for the formation of investment policy in this area;

- 5) development of proposals for the development of the sports industry;
- 6) Creation of a scientifically based system of health improvement and physical education of the population, development of children's and youth sports, ensuring the use of physical culture, sports, sports tourism and resorts for social adaptation, and rehabilitation of disabled people and persons with weakened health;
- 7) creation of conditions for the participation of individual amateur athletes, sports clubs, local, regional and national teams, national representative teams in international amateur sports competitions, including the World Amateur Sports Games under the aegis of the International Council of Amateur Sports.
- 8) development of cooperation with state and international organizations in the field of the relevant sport and sports tourism and interaction in the established manner with state and interstate authorities in the coordination of international cooperation.
- 9) development and implementation of information and promotional activities and publicity events in order to develop the appropriate sport and sports tourism.

5. The Committee for the sports of the International Council of Amateur Sports performs the following functions in accordance with the tasks assigned to it:

- 1) develops draft regulations and regulations for amateur sports competitions in the appropriate sport.
- 2) participates in the established order in the development and implementation of sports programs of the International Council of Amateur Sports.
- 3) analyzes the status of the relevant type of amateur sports and sports tourism, inform the International Council of Amateur Sports in the prescribed manner on the state of affairs in these areas;
- 4) develops and approves, in accordance with the established procedure, standards for determining the level of various categories of amateur players;
- 5) provides training, retraining and advanced training of specialists in the field of amateur sports and sports tourism;
- 6) develops and approves the international sports classification and a single calendar plan for amateur competitions under the auspices of the International

Council of Amateur Sports, and also introduces in the established order new sports subspecies within the scope of their competence in their sport's view into amateur competition programs.

7) organizes mass sports competitions, sports games, sports days, sports and sports festivals, other sports and recreational and sports events under the auspices of the International Council of Amateur Sports;

8) conducts contests, correspondence and part-time competitions between physical culture and sports organizations, educational institutions and other organizations, regardless of the organizational and legal form for determining the best organizer of work in physical culture and sport, exercises moral and material encouragement to the winners of these contests and competitions;

9) participates within the limits of its competence in the organization of physical culture and health and sports work with disabled people, persons with weakened health, holding sports and recreational activities with them, training disabled athletes for national and international sports competitions and directing them to such competitions;

10) participates in the development of the research base and the improvement of the system of scientific and methodological support of activities in the field of physical culture, sports and sports tourism;

11) promotes the development of sports medicine, participates in activities to combat the use of doping in sport;

12) participates in the established order in the development of measures for the social protection of amateur athletes, coaches and other employees in the field of amateur sports and sports tourism;

13) provides the creation of conditions for work and professional development of coaches and amateur athletes;

14) participates together with the relevant executive authorities in developing measures to ensure public order and security when conducting mass events at sports facilities and organizing sports tourism;

15) conducts scientific and scientific-practical conferences, seminars, symposia, organizes exhibitions and other events within its competence;

16) participates in the established order in the development of state and international educational standards for basic general education and professional education in the field of sports;

17) in accordance with international law and national legislation participates in the organization of work on holding auctions and sports lotteries;

18) develops and approves, in accordance with the established procedure, regulations on awarding sports ranks, appropriates sporting ranks, awards medals, diplomas, prizes and other awards to winners and prize-winners of international sports amateur events;

19) participates in the preparation and conclusion of international treaties with foreign states on cooperation in the field of amateur sports and sports tourism;

20) on behalf of the International Council of Amateur Sports, represents the interests of the International Council of Amateur Sports in the international sports and sports organizations, ensures in the established manner the formation and coordination of the activities of parts of intergovernmental commissions in the field of amateur sports and sports tourism;

21) exercise in due course the accreditation of physical culture and sports associations participating in international sports events on behalf of the International Council of Amateur Sports ;

22) participates in accordance with international law and national legislation in the licensing of activities for the provision of sports and recreational and sports services in the field of amateur sports and in the mandatory certification of goods and services in the field of amateur sports and sports tourism;

23) takes within its competence participation in the improvement of the international system of standardization and certification of goods and services, as well as in the development of international and national rules and regulations in the field of amateur sports and sports tourism;

24) develops and approves in accordance with the established procedure the industry standards in the field of amateur sports and sports tourism, exercises control over their observance;

25) carries out the propaganda of amateur sports and sports tourism in the mass media, participates in ensuring the publication of mass, popular scientific and educational literature, the production of TV programs, video and film materials on this topic;

26) in accordance with the established procedure participates in the distribution of targeted financing under the programs of the International Council of Amateur

Sports for organizations - target-recipients in the field of amateur sports and sports tourism;

27) participates in the established order in the development of financing standards by the International Council of Amateur Sports of Amateur Sports organizations and international tourism;

28) within its competence establishes the procedure for holding international amateur sports events included in the calendar plan of the International Council of Amateur Sports;

29) develops, in accordance with the established procedure, proposals on payment terms for coaches, physical culture and sports organizations employees, as well as drafts of tariff-qualification characteristics for occupations and positions of employees in the field of amateur sports and sports tourism;

30) develops together with interested organizations proposals for improving statistical reporting in the field of amateur sports and sports tourism.

6. The Committee for the sports of the International Council of Amateur Sports has the right to:

1) request, in accordance with the established procedure, information from international and national executive authorities, local self-government bodies, legal entities and individuals on matters within the competence of the Committee;

2) attract in the established order to study the issues falling within the competence of the Committee, scientific organizations, as well as individual scientists and specialists;

3) develop and implement, in accordance with international law and national legislation, measures to improve social protection and labor protection for the employees of the Committee and its organizations;

5) conclude, in accordance with the established procedure, agreements with international and national executive authorities, commercial and public organizations on cooperation in the field of amateur sports and sports tourism;

6) create a scientific council, advisory and other councils, commissions and working groups on the most important problems of amateur sports and sports tourism;

- 7) conduct scientific research in the prescribed manner in the field of amateur sports and sports tourism;
- 8) establish, in accordance with the established procedure, awards, to approve the regulations on these awards, their description, the provisions on assigning qualification categories and honorary titles to trainers-instructors, instructors-methodologists;
- 9) hold conferences, meetings, seminars, symposiums, organize exhibitions, reviews, competitions and other events in the field of amateur sports and sports tourism;
- 10) implement in the established manner information and advertising and publishing activities on amateur sports and sports tourism.

7. The Committee for the sports of the International Council of Amateur Sports is headed by the Chairman, who is appointed and dismissed by the Secretariat of the International Council of Amateur Sports.

8. The Chairman of the Sports Committee of the International Council of Amateur Sports has deputies appointed and dismissed by the Secretariat of the International Council of Amateur Sports. The number of deputy chairmen is established by the Secretariat of the International Council of Amateur Sports.

9. Chairman of the Committee on the Sports of the International Council of Amateur Sports:

- 1) manages the activities of the Committee and bears personal responsibility for the performance of the tasks assigned to the Committee and the exercise of its functions;
- 2) establishes the powers of his deputies, assigns responsibilities between them;
- 3) submits to the Secretariat of the International Council of Amateur Sports drafts of regulatory and normative acts in accordance with the established procedure;
- 4) issues, within the limits of its competence, orders, orders and verifies their execution in accordance with international and national laws;

5) approves the provisions on the structural units of the Committee, the structure and staffing of the Committee's staff.

6) in accordance with the established procedure, appoints and dismisses employees of the Committee's staff;

7) ensures in due course the interaction of the Committee with other structural bodies of the International Council of Amateur Sports.

10. Members of the Committee on the sports of the International Council of Amateur Sports.

1) Members of the Committee are individuals - representatives of the relevant sport, co-opted by the Chairman of the Committee on the sports:

- famous amateur players and professional players;

- representatives of the organizers of amateur competitions;

- representatives of international and national federations in the relevant sport;

- judges;

- public and state figures, representatives of science, culture and business involved in the international and national sports amateur movement;

2) The number of members of the Committee for the sports: not more than 20 persons;

3) Powers of the members of the Committee: At its meetings the Committee reviews the main issues of the Committee's activities. Decisions of the Committee are made by a majority of votes of its members, are drawn up by protocols and implemented by orders of the chairman of the Committee.

4) In case of disagreement between the chairman and the members of the Committee, the chairman takes decisions, reporting on the differences that have arisen to the Secretariat. Members of the Committee can also communicate their views to the Secretariat.

11. Financing of the expenses for the maintenance of the apparatus of the Committee for the sport is carried out at the expense of the funds of the International Council of Amateur Sports of the Council, envisaged for public administration.
